Latest Information and Response

Mr. Walker shared a graphic showing the spike in COVID-19 cases. Mr. Walker advised that an email was forwarded to all staff this week as a reminder to continue to abide with the safety precautions in place especially now that the Keys are open to visitors and the spike in cases in Florida.

Mr. Walker reported that FKAA has joined several hundred utilities around the country that are testing for COVID-19 in the collections system. He explained that the FKAA's Cudjoe facility is participating in the testing process and will monitor the amount of COVID-19 detected in the samples which will help identify possible hot spots in these service areas. Mr. Walker advised that once results are received the Board will be updated.

Mr. Walker advised that all staff have moved out of the 1100 Kennedy Drive Administration Building and demolition is scheduled to occur in approximately 2 weeks.

Current Financial Status

Mr. Shelby reported revenue was down in May attributed to the pandemic and the start of rainy season. Mr. Shelby advised that revenue is flat, and volume is behind by approximately 3%.

Mr. Shelby advised that the number of delinquents are down and continue to improve.


